

AGREEMENT
between
GRADUATE SCHOOL OF SOCIAL WELFARE
EWHA WOMANS UNIVERSITY, REPUBLIC OF KOREA
and
FACULTY OF SOCIAL ADMINISTRATION, THAMMASAT UNIVERSITY,
THAILAND

This AGREEMENT is made between the Graduate School of Social Welfare, Ewha Womans University and the Faculty of Social Administration, Thammasat University hereinafter referred to institutions.

The aim is to establish and develop a close partnership to promote joint research and academic exchanges between the two institutions.

1. Tutor exchange

Each institution may receive members of the partner institution to give a lecture, to receive training, and to engage in joint or individual research in support of sabbatical leaves, or to exchange views to further these objects.

2. Student Exchange

Each institution may accept students from the partner institution for further studies including practical training and other training opportunities. The procedures and other details involved in this exchange shall be subject to discussion and agreement.

3. Joint Research/ Seminars

The Faculty of the two institutions shall actively explore areas of joint research and will cooperate in sponsoring seminars, symposia and research conferences, the collection of research materials and data, the exchange of information, and the publication of research findings.

4. Sponsorship

Both institutions shall collaborate in the sponsorship of conferences, colloquia and seminars on topics of significance to social work and social welfare.

5. Administration

The Graduate School of Social Welfare and the Faculty of Social Administration, aided and assisted by their colleagues and other appropriate institutional structures, will be responsible for administering this program.

6. Financial Obligation

This agreement shall impose no financial obligation on either institution. Exchange terms and related matters shall be discussed and determined according to the principle of mutual equality.

7. Revision

Any amendment and/or modification of the Agreement require consultation and an agreement between the two institutions and shall be appended hereto.

8. Termination

This agreement shall become effective upon signing by both institution and may be terminated at any time by mutual consents. Termination of this agreement should be made after writing and giving a six-month notice.
