



The Faculty of Social Administration, Thammasat University Announcement

Subject: Recruitment Extension for the Position of Permanent Lecturer

Round 3/2022

Following the announcement of the Faculty of Social Administration, Thammasat University on Recruitment for the Position of Permanent Lecturer, the Faculty of Social Administration has decided to extend the recruitment period until 30 June 2022 with the following details.

1. Required Position

1.1 A position of Permanent Lecturer for the Social Policy and Development programme (international programme), Department of Social Policy, Social Development, and Community Development.

2. Conditions:

- 2.1 The selected applicant will be approved by the Executive Board of the university.
- 2.2 The selected applicant will be able to work at the Tha Prachan, Rangsit, and Lampang campus if assigned. The applicant will show his or her consent in the document provided after passing the selection process.
- 2.3 The selected applicant will be able to work on other programmes of the faculty as assigned.

3. Qualifications:

3.1 Qualifications

The candidate should meet all of the following criteria:

3.1.1 The applicant has a doctoral degree in a field which has relevance to Public Policy and Social Policy, Social Work and Social Welfare, International Development, Social Development or Community Development, from international programme

OR

3.1.2 The applicant has a doctoral degree in a field which has relevance to Public Policy and Social Policy, Social Work and Social Welfare, International Development, Social Development or Community Development from an institute accredited by the Office of the Civil Service Commission or listed in the Office of the Civil Service Commission for Universities.

3.1.3 The applicant shall have experience of working, teaching or researching in Public Policy and Social Policy, Social Work and Social Welfare, International Development, Social Development, Community Development or in a relevant field. Employment certificate may be required as evidence.

3.1.4 The applicant will be in possession of a completed thesis and research or written academic papers related to Public Policy and Social Policy, Social Work and Social Welfare, International Development, Social Development or Community Development completed within 5 years prior to 31 May 2022. The submitted work must not be part of the applicant's degree. Applicants who have published their work in an academic journal registered in TCI or SCOPUS database are desirable.

3.1.5 Applicants who hold an academic title such as “Assistant Professor”, “Associate Professor”, or “Professor” are exempted from the qualification numbers 3.1.1 and 3.1.2. The appointment process of an applicant’s academic title should adhere to the standards in Thammasat university regulations on “Principles and Criteria to Appoint an Academic Title to Permanent Lecturers” or “Announcement of the Office of the Civil Service Commission for Universities on the Appointment of an Academic Title to Permanent Lecturers.”

3.1.6 Applicant shall have one of the following English test scores. The test score must be valid from a test taken within 3 years before the date of application submission.

Test	Score
(1) TOEFL	
- Paper Based (out of 667)	550
- Computer Based (out of 300)	213
- Internet Based (out of 120)	79
(2) IELTS (out of 9)	6.5
(3) TU – GET (out of 1,000)	550
(4) CU – TEP (out of 120)	75

For applicants who do not meet the above English test criteria, if the faculty considers that the candidate has potential to pass the test, the faculty may propose the exemption to the university under the condition that the selected applicant will provide the required English test score within two years from the commencement of employment.

Applicants who fall into one of the following criteria will be exempted from the submission of the English test score.

1. Applicants who have graduated from an international programme or a programme taught entirely in English, which is acknowledged by the Office of the Civil Service Commission or is in the list of the Office of the Civil Service Commission for Universities.

2. Foreign applicants shall have a very good command of English in all skills.

4. Application

4.1 Applicants may download the application from the website <http://www.socadmin.tu.ac.th> and submit the application form and all required documents by two means:

- Submit the completed application form and all required documents in person at the Office of the Secretary, 2nd Floor, Faculty of Social Administration building, Thammasat University (Rangsit Campus) from now until 30 June 2022 from 09.00 AM to 03.30 PM (except weekends and official holidays).

4.2 Required Documents

- 4.2.1 A fully completed application form
- 4.2.2 A copy of bachelor's degree, master's degree, and/or doctoral degree with transcripts. Original documents will be verified.
Non-Thai and English documents are needed to be translated either in Thai or in English.
- 4.2.3 An English test score certificate as indicated in Section 3.1.5
- 4.2.4 A copy of passport / A copy of ID card

- 4.2.5 A copy of name or surname change certificate (if any)
- 4.2.6 One official photo, one- or two-inch square without hat and sunglasses taken less than a year ago
- 4.2.7 A medical examination certificate issued within 3 months for the following diseases/symptoms
 - (1) Tuberculosis
 - (2) Severe elephantiasis
 - (3) Drug addiction
 - (4) Alcoholism
 - (5) Chronic renal failure
 - (6) Dementia
 - (7) Severe mental disorder
 - (8) Pestilence or chronic diseases that obstacles daily work
- 4.2.8 Three recommendation letters from persons who know the applicant well, excluding letters from applicant's father, mother, husband, wife or siblings. One of the referees needs to be (a) graduated civil servant or permanent employee of a government unit or a state-enterprise, (b) a policeman or soldier who ranks at least captain position or (c) dissertation supervisor or committee, director, or dean. The addresses and telephone contact details of the referees are required.
- 4.2.9 A certificate of work experience and/or a list of related experiences or outstanding expertise (if any)
- 4.2.10 A copy of PhD and MA dissertation, and academic and research paper

Please note:

Academic works stated in section 4.2.10 will be returned to the applicant after the selection process finishes.

6.3 Announcement of written examination date, And psychological and EQ test	20 July 2022
6.4 Submission date of Academic article writing	1 August 2022
6.5 Announcement of a list of eligible candidates for teaching test and interview	10 August 2022
6.6 Announcement of teaching test and interview date	18 August 2022
6.7 First round announcement of the selected candidate.	24 August 2022

Please note:


- Psychological and EQ test fee costs 500 baht.
- In the case of unforeseen circumstances, the announcement of the teaching test date, interview date, and selected candidates shall be postponed.

7. Announcement of a Successful Candidate

The faculty will post the result at the Faculty of Social Administration and on the faculty website <http://www.socadmin.tu.ac.th/> by ranking applicants according to scores received. The university Executive Board will make the final decision. If the selected candidate proposed by the faculty is not approved by the university Executive Board, the faculty will propose the applicant listed in the second rank to the university.
